>>Substation Upgrade project at Andrews Air Force Base in Maryland.

Exciting news: The Substation Upgrade project on Andrews Air Force Base (Andrews AFB) in Maryland started again!

In 2014, MTNT Energy, LLC (MEL) was awarded a multi-million dollar contract to rebuild the substation at Andrews AFB. This was an exciting time as it was the largest contract awarded to MTNT. It came with great hopes to gain past performance in large scale projects and enable MTNT to increase our revenue stream. Unfortunately, it became evident late last year that the project did not start off well, causing many delays.

After nine months and many negotiation sessions with the government, MEL achieved a milestone through a settlement. The issues were resolved and MEL is back to work on site.

MEL has a solid team in place that will bring this project to completion and lead to more successful work in the Northeast area. The partnering and teaming relationships that MEL has built with the customer, the U.S. Army Corps of Engineers, on Andrews AFB is certainly a big part of making this project a success for the MTNT family.

MESSAGE FROM THE CHIEF EXECUTIVE OFFICER



Greetings MTNT Shareholders,

We are delighted to announce that during the summer, MTNT's cumulative distributions to shareholders via dividends topped \$4 million since MTNT's first dividend was issued in 1988. Moving forward, MTNT's Board of Directors, employees and officers will continue to implement and evaluate the corporation's strategic plan. aligning partnerships and capitalizing on opportunities that promote the mission of MTNT: to increase corporate profitability, provide shareholders with economic benefits and opportunities, and to protect our corporate assets and land base, while recognizing the traditional cultural values and subsistence lifestyles of our Shareholders.

One opportunity we are evaluating and monitoring closely is the potential benefit of the 2017 Tax Act signed into law in December 2017 which included an Amendment related to the Alaska Native Claims Settlement Act 39 (1)(b) and 1988 Legislation which authorized Alaska Native Corporations to establish Alaska Native Settlement Trusts to hold and manage Native owned assets in perpetuity to promote the health, education, and welfare of its beneficiaries and preserve the heritage and culture of Alaska Native people.

The new tax amendment allows Alaska Native Corporations to transfer cash and/or assets to a Settlement Trust on a pre-tax basis while allowing for nontaxable distributions to be paid to the shareholder-beneficiaries of the Trust. This means that if a Settlement Trust was established and dividends distributed through the Trust, the income would be tax free to the Shareholder.

In addition, the new tax law is intended to reduce the overall taxes on the Corporation's 7(j) income if placed in a Trust, reducing taxes from an average of 25-percent down to 10-percent. The reduction in taxes would potentially allow more money to be available for future distributions and/or investments.

We will provide updates as we learn more about the 2017 Tax Act, as well as the pros and cons of establishing a Settlement Trust.

While we are looking at a diverse array of opportunities from reducing taxes to forming business partnerships, MTNT continues to streamline business processes, cut costs and improve operational efficiencies to provide meaningful benefits to our Shareholders and their families.
